A Message from Br. Joseph Fox, C.S.C.

On behalf of the Holy Cross Village Foundation Board, I would again take this opportunity to thank those who have made an impact possible either with spiritual, financial, and moral support in each of our endeavors. Without your support our accomplishments would not be realized.

Let me highlight for you some of those accomplishments. They include:

In 2018, Andre Place's dining room was provided 150 new dining chairs. With the design and comfort of these chairs, we all benefit. Private care rooms in Dujarie House were provided power lift chairs—just another way to make life a little bit easier for those in our acute care facility. Also at Dujarie House is a brand new Therapy and Rehab center. The comfort and beauty of this spacious facility is second to none.

In 2019, a passenger Lift Bus was purchased, providing us the freedom to transport our residents to doctor's appointments or recreational outings, without having to rely on availablity and cost of commercial service.

COVID-19 entered our life in 2020 making life very difficult for all of us. However, the team focused on working to complete phase one of the Dujarie House improvements. This gave the residents a new dining room and library/parlor, complete with a fireplace. Do stop in to get a first-hand view of this beautiful and relaxing space.

The stair lift project for Dujarie was also realized. We purchased battery-operated, motorized chairs to safely move our residents from one floor to another in the event of a power failure or fire. Andre Place, Riverside Place and Schubert Villa have also been equipped with similar equipment.

After COVID lost its grip on us, we were able to finish refurbishing the dining room in Schubert Villa. It also has a fireplace and baby grand piano to provide dinner music for our Schubert residents. Just outside the dining room, on the front porch, you will find a very relaxing setting for entertaining your visitors.

The year 2021 was spent with special concentration on enhancing the beautification of our spacious grounds. If you haven't yet ventured to the two areas overlooking the St. Joseph River, you need to do so before winter sets in.

Come along with me and experience the beauty of the Gardens & Pathways for everyone to enjoy. As you enter the walkway between the Rehab Center and St. Joseph Place, you approach the Mary Coquillard walkway with a lovely sitting area. Continue on to the Charlotte Sydor garden. Going a little further, we come to the Carol Mylod overlook over the St. Joseph River. Heading south, along the river, you will find the Pavilion. This structure provides shade and an area to step out of the rain or snow. Just a short walk ahead, in the Dujarie Garden, you will find a gazebo to rest. We then enter the beautiful Roemer Garden. Still heading south, as you approach the front of Riverside Place, you come across the Welsh patio, providing another rest stop. Heading along the walkway to the south end of Riverside Apartments, another gazebo appears as well as another overlook of the lazy flowing St. Joseph River. Having witnessed the beauty and well-groomed Gardens and Pathways, as well as getting in our steps for the day, we can all head back to our apartments for a refreshing beverage.

Much has been completed over the past years to benefit the residents of the Village and we have much more work to accomplish. The Impact Statement 2023 reflects our achievements and appreciation of our residents, their families, team members, and community members who believe and support our mission. Campus Beautification – Jim Bowman

A healthy, life-giving garden requires a fertile foundation, plenty of light, water, nutrients, and tender loving care. Life can be viewed as a garden; with care and love, beautiful memories are cultivated that last a lifetime.

This saying holds true for Jim Bowman and his late wife, Joyce Kevorkian. They both were gifted a second opportunity for love and readily shared their personal story with friends and residents of Holy

Cross Village. Additionally, they also shared this love with others by the simple act of planting spring annuals around the front sign at Holy

Cross Village, Andre Place.

Starting the tradition in 2017, Jim and his late wife, Joyce, planted 96 annual flowers, adding vibrant color to the drive along Holy Cross Parkway. Jim lost Joyce in October 2021, and through the gift of love and to honor Joyce, increased the spring planting from 96 flowers to include 144 plants comprised of assorted vinca and coleus.

Jim today continues the planting tradition to honor Joyce and to bring joy to the residents of Holy Cross Village. We share with you one of Jim's favorite quotes:

"If I had a flower for every time I thought of you, I could walk in my garden forever!"



The Joy of Music – Jack and Susan Fuhrer

Susan began playing piano at age four. Since then, playing the piano has brought her great joy. Her husband Jack proudly states, "Music is part of her soul."

Susan was a piano teacher for twenty-five years. Susan's special gift was her ability to help her students love playing the piano. When Susan was interviewed by the parent of a prospective student, Susan would say, "If you want your child to win competitions and go on to Julliard in New York, then I'm not the teacher you're looking for. However, if you want your child to love playing the piano, then I'm the right teacher.

As Susan's kids were becoming young adults, her love for music moved her to pursue a music degree at Westminster Choir College. After graduating Summa Cum Laude form Westminster in 1992, Susan purchased herself the perfect graduation gift... a Yamaha grand piano.

In 2002, Susan suffered a massive stroke that completely paralyzed her left side. However, as soon as Susan could sit strongly in her wheelchair, she continued playing the piano, now only with her right hand.

In 2012, Susan and Jack moved from their home in Arizona into Andre Place. Susan continued with the piano and proudly performed concerts in Br. Geenen Hall in 2014, 2016, and 2018, playing selections by Bach, Beethoven, Gershwin, and many more. In those concerts, Susan's local piano teacher played along with her, playing what Susan wished she could be playing with her left hand.

In 2022, the Fuhrers generously gifted the piano to Holy Cross Village Foundation. Susan was thrilled to know the piano would be housed in Br. William Geenan Hall, Andre Place, and be available for resident use. For seven decades, Susan found great joy at the piano. Today, her piano brings joy to Andre Place residents. Thank you, Susan and Jack, for sharing your joy with us!

Helen D. Schubert Villa Dining Room Renovation

With the renovation completed on The Philip L. Quinn Memory Care Center and Dr. Charles Schwartz wing (14-long term care suites), Holy Cross Village then moved forward with scheduled renovation of key areas located in Helen D. Schubert Villa. Residents identified improvements were made to enrich the dining experience, with relocating the Schubert Villa main entrance corridor from the main dining room.

With renovation completed, the dining area is now transitioned into a semi-privated area with a closed corridor. This same space has been retrofitted for multi-purpose use to accommodate group activities during off dining hours. A final touch added ergonomically designed furniture and an outdoor patio. This outdoor space is now available for resident and guest use. Coming this fall is scheduling patio landscaping.



The Power of Music at Holy Cross Village (Jazz Enrichment Br. Lew Brazil)

Music is often identified as entertainment, in which multiple sounds come together in a way we all enjoy. Music, however, is often used to accomplish other purposes such as dance, communication, and ritual performances. Through the gift of music, Br. 


Special Mention of Gratitude

The Holy Cross Brothers remain active sponsors of Holy Cross Village and financial gifts fully support many of the much-needed capital improvements accomplished this fiscal year. We've shared with you the completion of the Dujarie House renovation, Schubert dining room renovation and the addition of a new patio outside the Schubert Dining area. Landscaping is scheduled for late fall of this year.

Your generosity to Holy Cross Village enables the Foundation to provide a cumulative gift of \$654,953 to support Holy Cross Vilage at Notre Dame. Through the generous donations, we were able to provide \$639,700 to support Mission Purposed projects, fund \$9,120 in employee support programming, and direct \$6,133 to resident enrichment programming.

As we look forward to our next fiscal year, additional mission-purposed projects are scheduled to include Br. William Geenan Hall Conference/Video upgrade, Riverside Place patios, and two memorial gardens. Without donor support, many of the mentioned projects would not be accomplished. 
